Introduction:

Jim welcomed the attendees to the meeting and reviewed the agenda.

New Organizational Structure:

The group discussed the possibility of electing official officers to serve as the Chair and Co-Chair of the Consortia. The group agreed to move forward with this and Jim will draft a document with the Roles and Responsibilities for the Chair and Vice-Chair. Jim will begin collecting the names of volunteers and nominees for the election. The nominations will close on September 15. The question of applying to the ISTAART organization to become a Professional Interest Area (PIA) was raised. This remains an open question and will need further investigation.

Educational Webinars:

Several topics for educational webinars have previously been discussed such as:

- What are investors looking for?
- What is big pharma looking for when evaluating biotech partners?
- Regulatory guidance

All the topics were seen as of interest and appropriate for the Consortia. The frequency of webinars was suggested to be quarterly. Anyone interested in helping to organize a webinar should contact Jim.

Ramesh also mentioned the seminar series from the Indiana Health Industry Forum. It may be possible for AASCC members to connect on-line for these sessions. Ramesh will look into this possibility.

LinkedIn Group or Blog

The group discussed the potential to set up their own LinkedIn group to share ideas, references and to pose questions. This idea was supported and Jim will set up the group.

Raising Visibility

Ideas for raising the group's visibility were discussed. The AAIC poster could be recycled for the ADDF meeting in October. Rick and Charles will explore this possibility.
