Case management, or care management, is a service offered, usually for a fee, to families by professionals in the field. Case managers will coordinate care for an elderly client by first assessing the person's situation and needs, developing a plan of care, and then helping to implement that plan by securing and introducing services. The case manager will also provide ongoing monitoring of the person's situation and adjust the plan of care as needed.
