Adult Day Centers

Adult day care centers provide a structured setting where people with Alzheimer’s disease and other dementias enjoy group activities such as exercise and craft-making, while benefiting from personal counseling, therapy and other services. In addition, using a day care center provides a caregiver with a period of respite.

When choosing an Adult Day Center:

- Will your loved one be able to move around in a supervised and structured setting?
- Are the participants respected as they are now, with staff responding to and validating their experiences?
- Is the setting free of distraction, allowing easy and focused socialization with staff and peers?
- Is staff specially trained in Alzheimer’s care? Are staffing levels adequate?
- Do activities include exercise, music, cooking, and reminiscing groups? Ask for a list or printed schedule.
- Does the center provide on-site nursing services?
