### NURSING HOMES

Nursing home care provides an intermediate or skilled nursing setting for those who require more services. Some are designed to provide specialized care for persons with dementia.

#### When choosing a residential care facility:

- Observe how the environment promotes independence and comfort of the residents and provides safety and security.
- Ask if staff is continually trained on dementia care issues.
- Ask what kinds of programs are offered for people with Alzheimer's and how different levels of functioning are addressed.
- Ask if residents and family members can participate in creating and reviewing care and service plans.
- Talk with residents and visitors about their opinions of the facility and staff.
- See if residents look happy, comfortable, relaxed, and involved in activities.
- Ensure that you witness a typical day, arrive unexpectedly.
- Talk with staff working with residents—are they competent and content in their jobs?
- Spend time in a variety of facilities observing what goes on and how people are treated.
- Meet with the administrator and directors of nursing and social services.
- Visit a facility more than once before making a decision.
- Many facilities don't allow medications to be brought in with the patient so stocking up is inadvisable

**Respite Care** is the provision of short-term, temporary relief to those who are caregivers. This may be used for a short break, going on vacation or in case of an emergency, where the caregiver needs to find temporary placement or care for the person who they are caring for.

**Special Care Unit** is an Alzheimer's unit *defined* by Illinois Department of Health meeting their specific criteria; however, other facilities do offer Alzheimers/Locked Units, but may **not** be certified through the Illinois Department of Health.
