


## Land Acknowledgement

The Wisconsin ADRC respectfully acknowledges that the University of Wisconsin–Madison occupies ancestral Ho-Chunk land, a place their nation has called Tecipo [day-IOPS lsince time immemorial. In an 1832 treaty, the Ho-Chunk were forced to cede this territory. Decades of ethnic cleansing followed when both the federal and state government repeatedly, but unsuccessfully, sought to forcibly remove the Ho-Chunk from Wisconsin.

We acknowledge the circumstances that led to the forced removal of the Ho-Chunk people, and honor their legacy of resistance and resilience. This history of colonization informs our work and vision for a collaborative future. We recognize and respect the inherent sovereignty of the Ho-Chunk Nation and the other 11 Native Nations within the boundaries of the state of Wisconsin.

We recognize the region served by our outreach and research teams in Oneida exists upon lands ceded from the Menominee Tribe to the Oneida Nation. We acknowledge this land we stand upon today as sacred, historical, and significant to the Menominee and Oneida Nation, as are the lands of all First Nations People.

## An Ongoing Partnership


- Collaboration began in 2015 after members of the Oneida Nation Commission on Aging (ONCOA) sought to learn more about Alzheimer's disease
- In 2016 the Oneida Nation Alzheimer's Disease Community Advisory Board (Oneida CAB) was formed.

- 1 in 3 Indigenous elders 65+ are projected to develop dementia (compared with 1 in 9 from the general population)
- 1 in 6 American Indians and Alaska Native people 45 and older report problems with their memory that have gotten worse in the last year

# Underrepresented in ADRD Research

 As of March 1<sup>st</sup> 2024, of the 50,962 people included in the National Alzheimer's Coordinating Center (NACC) Dataset, "**326 identified as** American Indian or Alaska Native (AI/AN)

### Barriers to Access

### Practice Based Experts have found:

- Transportation and availability to medical care is more difficult in some parts of the country
- Many reservations are rurally located
- Lack of culturally sensitive and safe providers and educational materials with people seeking to manage dementia care
- Lack of resources, support, or referrals for caring for Indigenous elders at home


## Data Sovereignty

- Data sovereignty is the right to have jurisdiction over any data that is gathered and created in any sovereign entity, and sovereign entities should use that data as they see fit
- Researchers who work with Indigenous communities have a responsibility to respect and facilitate a community's right to oversee and own their data
- Tribal IRBs are being initiated
- Protects cultural integrity and culturally sensitive knowledge

# Project Methodology









- Review and examine current CICA/KICA assessments

- Review of pilot testing data and refine questions where needed






