




West Virginia Chapter Board Member 2025 Dr. Joseph Malone

Over the years, Joshua Higginbotham has learned that hard work pays off. He's always had an interest in politics and has been involved in the community from a noticeably young age. He served as a Student Ambassador in six European countries at age 15, worked as a Page in the United States Senate at 16, and was the President of West Virginia DECA and ran for their National

President the same year. At age 19, he ran a successful campaign to become the youngest Delegate in the West Virginia Legislature in 2016.

Later, at age 22, he was chosen to be the youngest Economic Development Committee Chairman in West Virginia history, worked on major legal and tax reforms, established charter schools & the Hope Scholarship, oversaw teacher and police pay raises, supported the largest infrastructure investments in state history, and brought businesses to the Mountain State.
