CDC Awards BOLD Centers of Excellence and Public Health Program Grants

Earlier this month, the Centers for Disease Control and Prevention (CDC) announced award recipients for the Building Our Largest Dementia (BOLD) Infrastructure for Alzheimer's Act grants. These awards will fund BOLD Public Health Centers of Excellence and Public Health Program grants to state, local, and tribal public health agencies. The BOLD Infrastructure for Alzheimer's Act is aimed at building, sustaining, and growing public health capacity to address Alzheimer's, dementia, cognitive health, and dementia caregiving across the country. BOLD activities align with recommended actions in the Healthy Brain Initiative's State and Local Public Health Partnerships to Address Dementia: The 2018-2023 Road Map and the Road Map for Indian Country.

The <u>BOLD Public Health Centers of Excellence</u> will each focus on one dementia-specific topic — dementia risk reduction, early detection of dementia, or dementia caregiving — to identify, translate and disseminate promising research findings and evidence-informed best practices, including those that address social determinants of health. Centers of Excellence will work nationwide with CDC, national partners, and public health entities throughout the country to ensure maximum impact and reach. The BOLD Public Health Centers of Excellence recipients are:

- Alzheimer's Association dementia risk reduction
- New York University School of Medicine early detection of dementia
- University of Minnesota dementia caregiving

The <u>BOLD Public Health Program</u> grants are awarded to state, local, and tribal public health entities. The funding will promote a strong public health approach to Alzheimer's and all dementias and focus on implementing HBI Road Map and Road Map for Indian County actions that promote risk reduction, early diagnosis, management of comorbidities, and reducing avoidable hospitalizations.
