Workshop Proposal Submission Deadline is January 13th, 2020

Now in it's 24th year, the Alzheimer's Association's Caregiver's Conference, provides family care partners and healthcare professionals with opportunities to hear from industry leaders, attend educational workshops, learn about local resources, visit with vendors, and network with hundreds of others with a shared experience.

Workshops are intended to educate and support learning. Presenters may not sell, promote or pitch any specific product, company, or service. Each workshop is 75 minutes in length, including time for questions and answers. (Presentation material should not be more than 60 minutes in length).

Procedures for Workshop Proposal Submissions

- To ensure inclusion in the review process, all proposals must be submitted by January 13th, 2020.
- Submit a separate completed proposal cover form (this document) with each proposal.
- Incomplete and/or handwritten proposals will not be reviewed.

A limited number of workshop slots are available. The Alzheimer's Association Northeastern New York Chapter's Conference Advisory Committee will review all submissions. Notification of decisions will occur by February 3, 2020. Proposals may be submitted via:
